A. Introduction:

F. Persistent Cookies:

We employ persistent cookies for the following objectives:

- Recognizing you as a unique visitor (represented by a numerical identifier) upon your return to our website, enabling us to customize content or advertisements based on your preferred interests or to prevent repetitive display of the same ads.
- Compiling anonymous and aggregated statistics that provide insights into how users navigate and utilize our site, aiding us in enhancing the structure of our Website.
- Internally identifying you through account-related information such as account name, name, email address, customer ID, currency, and location (geographic and computer ID/IP address).
- Distinguishing users within the same network to ensure accurate allocation of Transactions to the appropriate account.
- Managing research surveys to avoid excessive invitation frequency or unnecessary repetition of questionnaires you may have already completed.

G. Third Party Cookies:

This site utilizes cookies served by third parties, which serve the following functions:
